

Presidio School will be continuing to offer food service for breakfast and lunch the week of March 23rd - March 27th, 2020 via a drive-thru style of pickup. We ask that you pull into the 1695 campus east entrance and pull forward to the Main Office where the student drop-off lanes are located. Please do not get out of your vehicle. We will come to your vehicle, count the number of children present, and then distribute enough meals for each child. Please then pull out of the west exit and continue west out of the parking lot onto Fort Lowell Road. We hope that by following these directions we can keep everyone safe and move the line efficiently. If you are taking public transportation or arrive on foot, there will be an orange cone on the sidewalk just east of the main doors. Please wait there and we will come to you. We will continue to offer meal service in this fashion as long as the mandatory school closure is in effect.

Meals will be available for pick up from 7 AM to 10 AM .

Meals are free to all children under the age of 18 years.

We can only distribute meals to children & the child must be present to receive the meals.

Snack packs will be available for pick up on Friday March 27th from 7 AM to 10 AM
